ELIGIBILITY: NRA membership is no longer required for people to compete in NRA tournaments. Competitors will still need to be an NRA member to set a **NRA National Record**

Rules: Current NRA High Power Rifle rules will govern. 'F' Class competitors welcome.

Individual entries: **Payment required with advance entries.** Entries without payment will be treated as walk-ons and will be squadded after payment is made. Please use entry forms at the bottom of page. **Please fill it out completely.**

Entries will be Squadded by NRA classification and close by July 20st at 9:00PM, late registrations will be squadded by availability with an effort to put high-masters and masters on the first relay if possible. SQUADDING TICKETS: All matches will be squadded. Squadding tickets for individual matches and team matches will be issued at the 200 yd line beginning at 7:00 AM. Please pick up your packets by 7:30AM. Squadding closes at 7:40 AM. Pits seal at 7:45 AM.

Classification: NRA High-power classifications will be used. Unclassified shooters will fire in the Master class. Be prepared to present your NRA Classification card. Rule 19.6- assigned Classification or 19.2 Temp. Classification may be used for this regional match.

EMPTY CHAMBER INDICATORS: ECI'S will be required and will be available at the range for \$ 1.50 each.

Rifles allowed: Rules 3.3, 3.3.1, 3.1, 3.1.1, 3.1.2, 3.1.3.

Sights allowed: Metallic only (Rule 3.7a)

Challenge fee: \$3.00 each if lost

Target operation and scoring: All competitors will be required to operate targets and score. A qualified substitute target operator will be allowed. Failure to complete target and scoring duties will result in disqualification and loss of match fees.

General Information: Lunch and drinking water will not be available. Outhouses are at the pits, 200yd line and the 600 yd line. Camping is allowed on the range at the small-bore and pistol ranges on top of the hill at no charge. The range gate will be unlocked by 6:00 PM Friday the 16th for campers.

New range rule: Eye protection required in the pits.

Divisions in Regional Tournaments: There will be two divisions, (providing there are enough of each type of weapon), NRA Match Rifle and Service Rifle. **Please indicate on entry card which type of rifle you are using.**

REGIONAL Hat Pins: All Competitors will receive a commemorative hat pin.

The High-power Rifle Range will be closed to live fire starting at 6:00 PM on Friday the 23th for match prep.

COURSE OF FIRE

SATURDAY, 8:00AM CDT JULY 23 2011

TEAM MATCH:

Two person teams. 10 shots SF 200 yards standing; 10 shots 200 yards rapid fire sitting or kneeling; 10 shots RF 300 yards prone; 20 shots SF 600 yards prone. No sighters during team match.

Advanced entry not required. Walk-ons welcome. Fees will be collected at 7:00 am at the 200 yd line.

Team captains will purchase team card from the match director, team fee \$14.00. Pickup teams welcome and encouraged

SATURDAY, 1:00PM CDT JULY 23th (or at the conclusion of the team match):

EXCELLENCE IN COMPETITION LEG MATCH:

Civilian Marksmanship Program 'Excellence in Competition' LEG match. Registration and squadding will begin immediately following the team match at the 200 yd line. Walk-ons welcome, no prior registration required.

START TIME: APPROXIMATELY 1:00PM AFTER TEAM MATCH

COURSE OF FIRE: 50 ROUND NATIONAL MATCH COURSE

FEES: **\$15.00 FOR COMPETITORS FIRING THE INDIVIDUAL MATCHES ON SUNDAY, or \$20.00 for LEG only**

AMMUNITION: AMMUNITION WILL BE PROVIDED BY THE COMPETITOR
COMPETITOR RULES: IN ACCORDANCE WITH THE CMP RULES and REGULATIONS (LATEST EDITION)

AWARDS: IN ACCORDANCE WITH AR920-30. NOTIFICATION OF AWARDS WILL BE CONFIRMED BY THE CMP AFTER SCORES ARE RECEIVED AND CHECKED BY THAT OFFICE.

NOTE: COMPETITORS WILL FIRE THE 200 RAPID FIRE IMMEDIATELY FOLLOWING THE 200YD STANDING WITH NO RELAY CHANGES BETWEEN THE MATCHES.

MATCH 1: 2 SIGHTING SHOTS AND 20 SHOTS FOR RECORD, STANDING, SLOW FIRE, 200YDS. SR TARGET, RULE 5.12

MATCH 2: 2 SIGHTING SHOTS AND 20 SHOTS FOR RECORD, SITTING OR KNEELING, RAPID FIRE 200 YDS. SR TARGET. RULES 5.8 or 5.10.

MATCH 3: 2 SIGHTING SHOTS AND 20 SHOTS FOR RECORD, PRONE, RAPID FIRE, 300 YDS. SR-3 TARGET. RULE 5.6

MATCH 4: 2 SIGHTING SHOTS AND 20 SHOTS FOR RECORD, PRONE SLOW FIRE, 600 YDS. MR TARGET. RULE 5.6

MATCH 5: SLOW FIRE AGGREGATE OF MATCHES 1 & 4

MATCH 6: RAPID FIRE AGGREGATE OF MATCHES 2 & 3

MATCH 7: REGIONAL CHAMPIONSHIP, MATCHES 1, 2, 3 & 4

NOTE- MATCH DIRECTOR RESERVES THE RIGHT TO CHANGE ANY OF THE ABOVE TO FACILITATE A SAFE AND SMOOTH RUNNING MATCH

NRA AWARDS
NATIONAL CHAMPIONSHIP CREDIT AWARD

Match Winner always receives A Gold medallion and an entry credit (no matter how many are in his class).

Match Second Recieves a Silver medallion

Match Third Receives a Bronze medallion

Only one credit certificate per person per year.

Class winners (other than Match Winner's class) receive an entry credit

providing there are ten

competitors in that class in the aggregate (Classes may be combined in order to achieve 10 entries).

Credit certificates earned will expire two years after date of issuing the award.
They must be used for entry or redeemed upon arrival for refund
