FIREARM LOAN AGREEMENT

These firearms are the property of the Iowa State Rifle and Pistol Association ("ISRPA"), and are intended for use in Civilian Marksmanship Program ("CMP") and National Rifle Association events, by both adults and juniors, to develop proficiency in the use of rifled arms.

Members will be responsible for the safe keeping of the firearm in his/her custody and will return the same in the same condition in which it was issued, less normal wear and tear. Storage and use of this firearm, while in the member's possession, must be in compliance with all applicable local, state and federal law.

The member will pay a fee of \$40.00 and post a deposit of \$80.00 (For a total of \$120.00) to the ISRPA General Fund. The \$80.00 deposit will be refunded upon return of the firearm, except as noted below.

The firearm will be returned to ISRPA Equipment Custodian no later than December 1 of the year in which it was issued, unless special arrangements are made with the Equipment Custodian IN ADVANCE. Failure to return firearm per this paragraph will result in forfeiture of deposit, and the rifle will be considered stolen.

If the member fails to provide proof that he/she fired the firearm in an NRA approved or registered match, or a CMP "Leg" match, deposit is forfeit.

If the firearm is damaged, other than through normal wear and tear, the member will pay full repair or full replacement value (per the Equipment Custodian). Deposit will be applied to repair/replacement.

If the firearm is lost or stolen, the deposit is forfeit and the member agrees to pay full replacement cost of the rifle as dictated by the Equipment Custodian of the ISRPA. Deposit will NOT be credited to replacement cost in this situation. Failure to pay this replacement cost will result in Small Claims Court actions by the Equipment Custodian of the ISRPA.
