LOCATION: Des Moines Rifle and Revolver Club range in Van Meter, IA, about 20 miles west of Des Moines. Take I-80 west from Des Moines to the Van Meter exit, # 113, turn south into town. Cross railroad tracks and take first left to range entrance.

ELIGIBILITY: NRA membership is no longer required for people to compete in NRA tournaments. Competitors will still need to be an NRA member to set a **NRA National Record**.

RULES: Current NRA rules apply.

SQUADDING TICKETS: All matches will be squadded. Squadding tickets for individual matches will be issued at the 600 yard line. Please pick up your packets by 8:30 AM. Squadding closes at 8:45 AM.

Be prepared to present your classification card. Walk-ons will be permitted to fill the line up. No additional relays will be added.

CLASSIFICATION: NRA Highpower Classification will be used. Unclassified shooters will fire in the Master class.

F-Class shooters welcome

EMPTY CHAMBER INDICATORS: ECI'S will be required and will be available at the range for \$ 1.50 each.

RIFLES ALLOWED: Current NRA highpower rifle rules will apply. Rifles with rainbow trajectories will not be allowed in the interest of pit safety.

CHALLENGE FEE: \$ 1.00 each

TARGET OPERATION AND SCORING: All competitors will be required to operate targets and score. A qualified substitute target operator will be allowed. Failure to complete target and scoring duties will result in disqualification and loss of match fees.

GENERAL INFORMATION: Lunch and drinking water will not be available. Bathrooms are available. Camping is allowed on the range, and the smallbore range on top of the hill at no charge.

COURSE OF FIRE: Sat 16 April 2011 at 9:00 AM.

MATCH 1: 2 SIGHTING SHOTS AND 20 ROUNDS FOR RECORD, PRONE,
SLOW FIRE, 600 YARDS, MR-1 TARGET, 22 MIN. TIME LIMIT.

ANY RIFLE, ANY SIGHT.

MATCH 2: REPEAT OF MATCH 1.

MATCH 3: 2 SIGHTING SHOTS AND 20 ROUNDS FOR RECORD, PRONE,
SLOW FIRE, 600 YARDS, MR-1 TARGET, 22 MIN TIME LIMIT,

ANY RIFLE, IRON SIGHTS.

MATCH 4: REPEAT OF MATCH 3.

MATCH 5: AGGREGATE OF MATCHES 1-4.

COURSE OF FIRE: Sun 17 April 2011 at 10:00 AM.

TEAM MATCH-TWO PERSON TEAM*, BLOCK TIME OF 47 MIN. PER TWO SHOOTERS, 2 SIGHTING SHOTS AND 20 ROUNDS FOR RECORD PER SHOOTER. MR-1 TARGET, PRONE , SLOW FIRE.

MATCH A: ANY RIFLE, ANY SIGHT.

MATCH B: ANY RIFLE, IRON SIGHT.

AWARDS: Award groups must contain at least five competitors or they will be combined with the next higher class. If there are fewer than five high masters, they must compete for open awards only. There must be five or more entries for one award, eight or more for two awards, and 11 or more for three awards. Special individual awards will be given for High Woman and High Junior and High Senior.

Match 1st, 2nd, 3rd (\$15,12,10) Class 1st, 2nd, 3rd (\$5,4,3).

DIVISION BY RIFLE: All matches will be divided by service rifle, match rifle or F-class.
